Vendors with prepared foods must also provide a <u>physical copy of a City of Rochester Vending Permit, and Physical Copy of Tax ID, OR a Monroe County Health Certificate, a Tax ID, Photo of Fire Safety inspection sticker (If using gas or propane), proof of Insurance \$ 1,000,000.00 (naming the City of Rochester as additional insured), photo of vehicle (including length) and copy of proposed menu.</u>

*Note: A tax Id is not about sales tax, it is about what you use for reporting your income on your income tax, ex: Social Security card, NYS Tax Certificate or Federal EIN letter.

RULES AND REGULATIONS:

- A. Placement starts at 3:15pm. You must check in with the Office or with the Guard near the Union Street Entrance when arriving. Placement does not go in order of arrival. Please be patient and you will be called when it is your turn to be placed.
- B. Your assigned area(s) must be left clean and free of litter at the end of event, do not leave anything behind, everything must go with you. All your cardboard boxes must be moved to the Cardboard compacter area in the Union Street lot.
- C. All items are to be confined within the boundary lines to prevent injuries and to facilitate foot traffic.
- D. Vendors must use the area assigned to them. Sub-licensing or sharing of your area is not permitted.
- E. Vendors are prohibited from hawking, shouting, using music etc., to attract customers.
- F. We do have the right to refuse anyone.

FAILURE TO OBEY THE ABOVE RULES AND REGULATIONS MAY RESULT IN TERMINATION OF YOUR PARTICIPATION AT THE MARKET.
